

**PRE-REGISTRATION: Extracts from the Notice of Race - Articles 3.2.1 and 4.1**

3.2.1 Pre-registration: a pre-registration procedure is available upon publication of this Notice of Race and through until 30 June 2020.

The pre-registration amount which is refundable in the event of non-participation , according to the terms set out in article 4, offers the following benefits:

- a priority position on the list of entries in order of arrival of the pre-registration forms and subject to compliance with the measures set out in chapter 4 (fees).
- registration fees with no surcharge prior to 1 July 2020.
- communication free of charge regarding the routing and climatology study for the GLOBE40 course carried out by the GREAT CIRCLE company.
- communication of the various logistics documents and technical products by the organisation during preparations for the race.

4.1 **Pre-registration:** the pre-registration amount is set at €2,000 ex. VAT; 100% of this pre-registration amount will be refunded in the case of a non-participation in the event being declared prior to 30 June 2020.
